

# RULES OF PROCEDURE

To be allowed to enter the campsite, you must have been authorized by the manager. Staying at Les Myrtilles campsite implies acceptance of the provisions of these regulations and the commitment to comply with them. Any offense may result in the expulsion of the perpetrator, with recourse to the police if necessary. Minors unaccompanied by an adult will not be admitted. Anyone who has to stay on the campsite must first prove their identity and complete the necessary formalities for registration.

**INSTALLATION:** The tent, caravan or motorhome and all the equipment must be set up in the location indicated by the person in charge of the reception office and not encroach on neighboring pitches. Under no circumstances will you be able to claim a specific location. As a precaution, for sites rented with electricity, bring an extension cord.

**NOISE AND SILENCE:** The users of the campsite are urged to avoid any noise and discussions which could disturb their neighbors. Sound devices must be adjusted accordingly and vehicle doors and trunks closed discreetly. People who disturb, make noise, damage equipment may be returned without warning and will not be reimbursed for their stay. Calm is essential between 10:30 p.m. and 7:00 a.m.

**ASSURANCE:** The camper must be insured. The campsite declines all responsibility in the event of theft, fire, bad weather and in the event of an incident involving the civil liability of the camper. All campers are required to comply with the campsite regulations. The responsibility of the campsite, beyond its legal responsibility is not engaged in the event of theft, loss or damage of any kind whatsoever, during or following your stay., Of nuisances due to natural phenomena (weather, insects etc. ...), breakdown or shutdown of technical equipment, breakdown or closure of campsite facilities, ad hoc measures taken by the campsite management, limitation of access to certain facilities including the swimming pool, required through compliance with safety standards or periodic maintenance work. As the deposit does not constitute a limit of liability, it is your responsibility to check whether your insurance contract provides for the "resort" extension. Otherwise, you must request an extension of warranty from your insurance company or take out a specific contract.

**POOL:** The swimming pool is open from July 1 to August 31. Access is free and reserved for campsite guests from 10 a.m. to 7 p.m. Swimming is unsupervised. Children should be under the supervision and responsibility of their parents or guardians. . Swimming shorts are forbidden, the wearing of the swimsuit is obligatory.

**PLAYGROUND:** Children should always be under the supervision and responsibility of their parents or guardians.

**Mini-golf :** the mini-golf is open on the same dates as the campsite opens. The rental of equipment (club, ball, and score sheet) is fixed at 1.5 € per player. Any damaged or unreturned material will be replaced at the player's expense.

**ANIMALS:** They must not be left alone on the campsite, even locked up, and must be kept on a leash inside the campsite. Their owners are required to take them out of the campsite for their needs, to collect their excrement and of course to keep them out of the toilets. 1st and 2nd category dogs are prohibited on the campsite. The animal's vaccination record must be presented on arrival. Any animal will incur a daily supplement. Only one animal will be accepted per accommodation.

**BARBECUE :** Wood and charcoal barbecue prohibited in the accommodation. You can use collective barbecues provided by the campsite.

**VISITORS :** After passing through the reception desk, visitors may be admitted to the campsite under the responsibility of the campers who receive them, upon payment of a fixed amount displayed. On the other hand, their vehicles must imperatively remain in the outdoor car park.

**VEHICLE TRAFFIC AND PARKING:** The speed is limited to 10km / h in the campsite. You must park on the site that has been allocated to you and must in no case obstruct traffic or hinder the installation of new arrivals by parking on neighboring sites. Traffic is prohibited at 10:30 p.m. and 7:00 a.m. In the event of a late re-entry, you must leave your vehicle in the outdoor car park.

**MAINTENANCE AND RESPECT OF THE FACILITIES:** For the well-being of everyone ... including yours, be sure to maintain cleanliness on the ground and in the sanitary facilities and to use the bins provided for each use for washing. The sanitary block is cleaned every day from 6 a.m. Please respect the job. It is forbidden to smoke inside the rentals, toilets, reception. All customers are required to comply with the internal rules of the campsite.
